Revised Order

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. And whereas, the Anand Education college Run by Shri Ramkrishna Mandal Managed, Nr. Electric Grid, Anand-388001 Gujarat by affidavit dt.05.01.2015 has consented to come under new Regulations and sought for one basic units in B.Ed, which require additional facilities

3. And whereas, it has been decided to permit the institution to have one basic units of 50 students subject to the institution fulfilling following conditions namely,

- I. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified perform available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- IV. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted along with the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.

4. Now therefore, in the light of the above and in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) hereby issues the revised recognition Anand Education college Run by Shri Ramkrishna Mandal Managed, Nr. Electric Grid, Anand-388001 Gujarat. for conducting B.Ed. programme of two years duration with an annual intake of 50 students (One Basic units of 50 students) from the academic session 2015-16 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

ORDER

In exercise of the powers vested under section 14(3) (a) of the National Council for Teacher Education (NCTE) Act, 1993, the Western Regional Committee grants recognition to Anand Education College, Opp. Electric Grid, Anand for B.Ed. course of one year duration from the academic session 2000-2001 with an annual intake of 40 students, subject to fulfilling the following conditions:

1. The institution shall appoint within a period of one year one additional teaching staff possessing the academic qualifications as laid down in the NCTE norms, the salary structure prescribed by the State Government.
2. All such teachers already appointed who do not fulfil the NCTE norms shall acquire the qualifications as per the norms within a period of two years of this order.
3. The institution shall ensure library, laboratories and other instructional infrastructure as per the NCTE norms.
4. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating university/State Government.
5. Tuition fee and other fees will be charged from the students as per the norms of the affiliating university/State Government till such time NCTE regulations in respect of fee structure come into force.
6. Curriculum transaction, including practical work/activities, should be organised as per the norms and standards for the course and the requirements of the affiliating university/body.
7. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
8. The institution, if unaided, shall maintain endowment and reserve fund as per NCTE norms.
9. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The Performance Appraisal Report should inter alia give the extent of compliance of the conditions indicated at 1 to 8 above.

Our previous order No. WRC/5-6/15/96/4065-67 dt. 01.07.99 is hereby cancelled.



In exercise of the authority vested under Section 14(3)(a) of the National Council for Teacher Education Act, the Western Regional Committee grants provisional recognition to Anand Education College, Anand for the following courses -

S.No.	Course	Intake	Period
1.	B.Ed.	108	Provisional recognition upto 1997-98

The institution does not fulfil the requirements for recognition laid down in the regulations notified in accordance with the provisions of the NCTE Act, 1993 and therefore the Committee further lays down conditions which are to be complied as follows -

1. Psychology lab. should be strenghtned.
2. Staff should be provided as per NCTE norms.
3. Curriculum transaction should be improved.

The institution is advised to send a compliance report upto 31 December, 97 as to the removal of deficiencies so that a new team may be sent to verify the same. The first priority should be given to the appointment of staff to bring the staff student ratio to 1:10. For 100 students 10 teaching staff members are needed apart from the principal. In case the institution does not appoint additional staff, the number of students to be admitted will be reduced from the next session in accordance with the student-staff ratio laid down by the NCTE, provided the institution is permitted to continue for the session 1998-99.

WITHDRAWAL ORDER

Whereas, the WRC had granted the recognition to Anand College of Education, Run by Shri Ramkrishna Mandal managed, Near Electric Grid, Anand, Gujarat - 388001 for conducting B.Ed. course with an annual intake of 100 students vide order No. WRC/5-6/15/96/4065-67 dt. 01.07.1999.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Anand College of Education, Run by Shri Ramkrishna Mandal managed, Near Electric Grid, Anand, Gujarat - 388001 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 05.01.2015 from the institution, a revised recognition order no. WRC/313009/2015/140818 dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 50 seats (one basic unit of 50 students) from session 2015-16.

And whereas, the WRC vide revised recognition order dt. 31.05.2015 had directed the institution to submit the followings documents in compliance of the NCTE Regulations, 2014 :-

1. List of teaching staff, duly approved by the affiliating body, appointed by the institution for each course.
2. Proof of maintaining the Endowment fund and Reserve fund as per NCTE Regulations, 2014.
3. A duly notarized building completion certificate (BCC) issued by the competent authority.

And whereas, the matter was placed before the WRC in its 276th meeting held on May 30th - 31st, 2017 to verify the compliance of NCTE Regulations, 2014 and the Committee decided to issue show cause notice dt. 12.09.2017.

And whereas, reply dt. 21.09.2017 was placed before the WRC in its 292nd meeting held on May 15th - 17th, 2018 and the Committee decided as follows :-

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 12.09.2017 was issued.

The institution vide reply dated 21.09.2017 has not submitted the required documents.

Hence, Recognition is withdrawn from the next academic session 2018-2019."

Now, therefore, the recognition of Anand College of Education, Run by Shri Ramkrishna Mandal managed, Near Electric Grid, Anand, Gujarat - 388001 for conducting B.Ed. programme of two years duration with an annual intake of 50 seats (one basic unit of 50 students), is **hereby withdrawn from the academic session 2019-2020** in terms of Section 17(1) of the NCTE Act, 1993.
